I.OPENING PRAYER- CALL FOR THE MEETING, DECLARATION OF QUORUM and RESOLUTION

The meeting was opened in zoom because our church building is closed due to COVID 19. Moderator, Rev. Peggy Casteel Huston, Interim Minister, welcomed over 80 members, opening with prayer at 11:07. She read the Call for Annual Meeting and the clerk declared a quorum.

MOTION made that the actions of the Congregation be the actions of the corporation. APPROVED.

The congregational at-large representatives to the 2021 nominating committee consists of 2 elders, 1 deacon, and 4 members-at-large who were elected by unanimous ballot. This committee will recommend members to serve on the Pastoral Nominating committee in addition to Elders and Deacons for 2022. **MOTION** to elect Jerri Gillette, Lance Boldrey, Brett Cone and Patty Wilson. **APPROVED.** Ellen Hoekstra will chair the committee in her role as Elder. Five mail in ballots were received.

IV RECOGNITION OF ELDERS AND DEACONS COMPLETING THEIR SERVICE

Pastor Peggy thanked the retiring Elders and Deacons for their years of service to this congregation: Elders: Nancy Frank, Laurin Gierman, Bill Given, Patty Wilson. Also to Paula Zichi and Gretchen Hill who resigned. Deacons: Kent Workman, Brett Cone, Barbara Hoevel and Esther Thorson and Jane Bobay. Jane Bobay will continue assisting the Deacons.

<u>V</u>. **REPORT OF THE ENDOWMENT COMMITTEE** – Ed Gillespie wanted to thank Stephanie Beckhorn and Christine Meland who are completing their 3 years on the endowment committee. He reported that they have \$420,146.77 in the endowment fund. To determine the amount to distribute, they take an average of the last twelve quarters and multiply by 5.5%. Last year it was \$19,650.00. The committee did some by-law changes (the by-laws are in the annual report) since the original start was a resolution. Some highlights were that they added that one session member will serve on the committee, the committee can disperse money without session approval once session tells them the annual amount to give out, and there would need to be a vote of session if the committee planned to invade the principal (which they have not done and have no intention of doing) **MOTION** to approve these small changes in the By-Laws. **APPROVED**

<u>VI.</u> BY-LAW APPROVAL – Part of Pastor Peggy's job is to make sure we have all appropriate documents for the church. We could not find any By-laws which we need for our incorporated status. A team worked on the By-Laws and session reviewed and approved the ones presented. But they must be voted on by the entire congregation. She asked for questions and two amendments were proposed: MOTION that. Line 67 would change to "votes on video conferencing technology should be done by the necessary supporting feature (e.g. raising and lowering of hand) and should be communicated at the beginning of the meeting" APPROVED

The next MOTION was "youth elders or deacons may be elected to a one year term in addition to the 12." APPROVED. Therefore on line 148 we would add "youth elders may be elected to a one year term in addition to the 12" and Line 173 would add "youth deacons may be elected to a one-year term in addition to the 12."

On Line 150 there was a clarification to add calendar in front of year.

MOTION to approve By-Laws as submitted with additional amendments approved today. APPROVED

VII. ELDER CHECK-IN TIME

A .Clerk's Report: Dorinda VanKempen addressed the significant membership drop and the process used to come to our current membership number of 291. Fifty-four were adult children of church members who were confirmed but never removed from the rolls. The other 217 were identified as not attending nor contributing to the church in the last 5 years. They were sent a letter, if we had a current address, and asked to respond about membership. We sent out more letters than the 217 and did get responses from those who wished to remain as members. When someone is no longer a member, they can't vote but can access all other services of the church or reinstate their membership if they desire. With this membership change, we also will be saving the \$35.23 per capita money we pay to the Presbytery with a total yearly saving of \$7,200.00. There were no other questions.

B. Staff Reports:

1. Rev. Peggy Casteel Huston - Pastor Peggy said her report is included and as always, contact her with any questions or concerns. She will discuss more about next steps at the end of the meeting.

2. Rev. Alice Fleming Townley – Pastor Alice's report is also included and she discussed how far we have come since the annual meeting last year. She outlined what we have done and accomplished, not only sustaining our ministry in a challenging time but expanding, doing hard work throughout. She knows we are in a good, good place and thanks us and encourages us as we move forward to what is ahead.

C. Session Committees:

- Administration: Jeff Arbour -The committee is proud that we were able to use our end of year surplus of \$27,000 for mission needs in the community. Also will be using the Roots and Wings campaign to continue funding for mission, personnel and paying off the mortgage in full by end of this year. This year's budget reflects the uncertainties with changes again with Pastors and church happenings so will be doing a midyear review. The \$15,000 gift from Bill Fritze was received to establish a reserve fund for large property projects and hopefully serve as an impetus for others to do the same. Happy to announce that the MOLD problem is fixed and there is no mold in the basement with our last testing. See the report for budget figures for this year and last. Garden Landscape report is outlined by Mary Lou Hatfield indicating work by various people with maintaining our garden and adding new plants
- 2. Endowment see above .
- 3. **Christian Education** Laurin Gierman thanked all education contributors for 2020 as they did wonderful things to not only keep the program going and strong but adding to it. See her report for further information.
- 4. **Communication and Engagement** Bill Given gave thanks to those who moved us to the on-line service in March and now working toward the move to live stream our services. The committee is also reaching out to help those who can't view the service, considering purchasing and tutoring those folks on ipads so they can participate. A plea also went out for volunteers to help with the live streaming once we get started.
- 5. **Mission** Nancy Frank said to look at her report outlining all the projects we have been able to support. We do local, state, national and international projects. There is something for everyone to do and thanks to the congregation for contributing money and time and talents in helping with the mission projects.
- 6. **Parish Life** Deb Major talked about the goal of Parish Life is to bring people together in fellowship which was difficult this last year. There were some on-line events and some small group meetings still occurring including the Retiree group. March 20 will be another on-line game night.
- 7. **Personnel** Emily Conroy-Krutz gives kudos to the staff for navigating their jobs in this tough year. Question about Pastor Peggy's length of stay and her contract is from August 1, 2020 to August 1, 2021 with chance to renegotiate if needed. Please see her report.
- 8. Self-Study Committee Ellen Hoekstra wanted to thank her committee for a job well done. They had a diverse range of skills and talents that worked well together to produce a 35 page report that got high marks with the Presbytery Committee on Ministry. It will now be used by the Pastor Nominating Committee for their work.
- 9. **Stewardship** Bill Given thanks his committee and Pastor Peggy with her stewardship sermons. Time and talent documents have been tabulated and are now available. The stewardship time went well.

- 10. Worship and Music Steve Mayhew said to review his report but highlights Alice's leaving the end of the month and that our Choir Director, Connor Koppin is completing his 3 years for his degree and will be leaving this year.
- 11. **COVID Task Force** Keith Camann has a detailed report but wants to thank staff and his committee for working together to keep us all safe. Special thanks to our Sexton, Edward, for managing the church for safe use. The committee used State of Michigan HHS emergency orders along with MIOSHA and OSHA guidelines to make their recommendations. A notebook by the mailboxes has all the data used by the committee. Things are encouraging as we slowly look to our next process for reentering the church!

C. Board of Deacons: An oversight as Deacons are not in the report, but will be added. Kent Workman gave thanks to all the Deacons for their ministry of caring, love, compassion and prayer. They do so much to care for the congregation. In many ways we are all Deacons, This past year, they have met more often to reach out and keep people involved so no one is left out. The "quiet shepherd" program has helped with that and thanks go out to Alice's leadership these last years.

For next steps – the nominating committee for 2021 will be starting their work to find and present names for the Pastor Nominating committee (PNC). These names will be brought to session and after that meeting, the selected names will be asked if they are willing to serve. Once those names are selected, we will have another congregational meeting to affirm those on the PNC.

Thanks to our staff for everything they do and to all members who make it possible to be a vibrant and present congregation and ministry for the gospel of Jesus Christ even in the midst of a pandemic.

PCO Endowment Fund 2021 Annual Report

The Endowment Fund was created in 2010 as a means of generating investment income to fund grant requests not included within the church's established operating budget.

The Endowment Fund Committee's (EFC) policy is to divide investment income between increasing the fund's principal and awarding grants. In 2021, the available balance for new grants was \$20,583 based on an invested principal of \$394,000.

2021 EFC members included Jeff Arbour, Dan Bollman, Ed Gillespie, Barbara Given, Jan Krehbiel and Ken Zichi.

This past year, the EFC conducted four Zoom meetings and four email voting sessions which led to awarding eight grants totaling \$12,157.61 benefiting the following committees: Christian Education, Personnel (PNC), Communications (Livestreaming), Worship and Music, and PCO's recently created Green Team.

Due to the pandemic, the EFC also monitored and made distributions for approved 2020 carry-over grants totaling \$3,950 (\$1,405.26 paid out, \$1,000 remaining to be paid, and \$1,544.74 in unused funds to be returned to the fund balance).

While the EFC's policy calls for disbursing funds within one year of grant approval, the committee has been flexible regarding distribution deadlines due to COVID-created circumstances.

A \$1,662 grant, awarded to the Green Team in December, will be disbursed in 2022.

This past year the EFC clarified and updated its by-laws, distribution policy and grant application process.

In anticipation of the EFC assuming the responsibility of overseeing PCO's Memorial Fund in the 2022, the committee also reviewed and made recommendations to update and amend the Memorial Fund's by-laws and distribution policy.

Over the past year, the Endowment Fund realized a 13.9 percent (\$54,850) return on investment, resulting in a 1/1/2022 principal balance of \$449,016.

EFC's 2021 financial transactions have been reconciled with those of PCO financial secretary, Doug Paterson, and determined to be in alignment with his records.

2021 Deacons' Annual Report

Our board of deacons has the focus of caring for others. During this long pandemic we have adjusted our ministry to help our church family in different ways. We meet monthly on a Zoom meeting. Our book study this year has been *Boundless Compassion* by Joyce Rupp. The reading and discussion have helped us to strengthen our interactions with people using more compassion and caring.

Quiet Shepherding: We have been striving to have some form of communication with every church member and special friend of our church. It could be in the form of an email, phone call, card or social media post.

Youth birthday cards: These have been sent out for all our youth to remind them that they are an important part of our church family.

Holiday cards: Easter, Thanksgiving and Christmas cards have been sent to members/church friends who are on our care and concern list. This list is compiled through our contacts with the Quiet Shepherd program, as well as finding individual needs that may have been given to our head of staff Pastor Peggy and/or Lisa Schrott.

Memorial service/funerals: We have coordinated many memorial services/funerals this last year. For a few we worked with the family to set up food, beverage and flower donations. Once COVID rates started rising again, we worked with caterers to set up food and beverages according to the requirements of our Covid-19 task force. We have provided ushers for many of these services, also.

Flower delivery: We delivered flowers from our services in the late summer and early fall when COVID rates were lower. These were given to people on our congregational care list, or to people who were in need of lifting up.

Nominating committee: One of our deacons, Jane Bobay, served on this committee and helped to find candidates to nominate for deacons and session.

Session liason: We send a deacon, Richard Norton, to each session meeting so he can share what we are doing and in return, Richard can share session news with the deacons.

Meal delivery: Jane Bobay has coordinated meal delivery via Meal Train which enables members of our congregation to provide meals for people who are in need during difficult times.

Visitation: We have tried to visit with people in person when the pandemic lessened. We especially wanted those in care facilities or the elderly living on their own to have contact with our church family.

We have tried to provide a conduit for the church family as we transitioned from interim pastor to no pastor to a new pastor. We have welcomed Lisa Schrott into our church family with open arms! It has been a challenging year for many reasons, but we hope that our ministry has helped in some small way to bind our church members/staff and friends together with God.

A big thank you to our outgoing deacons; Terri Grady (co-moderator), Jill Tribell (co-moderator and youth birthday cards), Catherine Holdway (secretary), Jane Bobay (meals and nominating), Sue Long (youth birthday cards) and Jake Stokes (youth deacon).

ADMINISTRATION COMMITTEE REPORT- 2021

Committee: Jeff Arbour (Chair), Doug Paterson, Siri Rainone, Dave Rumminger, Mike Stokes, Gary Sturk, Patty Wilson

The administration committee is responsible for the following:

Oversight of all financial, legal and insurance matters of the church.

Oversight of maintenance and use of the building and grounds.

Oversight of the newly formed Green Team.

Maintaining policies and procedures for numerous activities.

Our objectives in addressing these charges are:

1. Financial

- a. Coordinate development of the annual budget.
- b. Review the budget monthly to ensure record keeping and financial goals are met.
- c. Review and recommend any spending not related to other committees.
- d. Conduct an annual financial review

2. Memorial Fund

- a. Oversee the Memorial Fund account.
- b. Review recommendations for spending from that account for approval by Session.

3. Legal Issues

a. Oversee all matters of legal compliance and dealings with governmental agencies.

4. Insurance and Liability

- a. Maintain appropriate information on the status of insurance for Building and Grounds.
- b. Review policies annually or more often to insure adequate coverage.

5. Building and Grounds

- a. Maintain a list of necessary repairs.
- b. Communicate with the Building and Grounds committee regarding repairs.

6. Building Use

a. Approve/Disapprove all building use requests

- 1. Work with the Sexton to ensure proper use of the kitchen facilities.
- 2. Work with the Sexton to assure proper scheduling and use of facilities.

Budget is tracked and reviewed each month by bookkeeper Doug Paterson and is reviewed monthly by the entire committee. Recommendations for necessary adjustments are presented to Session.

The budget process for 2021 faced some uncertainties at the start of the year with the pending transition from interim pastor to newly installed pastor along with ongoing impact of the coronavirus pandemic. The budget for 2021 was \$590,700 and was adjusted to \$567,336 in November to reflect the reduction of actual expenses incurred during this transition period. This was the final year for the budget to receive \$112,000 from the Roots and Wings fund. This coincides with the mortgage being paid off in 2021 which represented a recurring annual cost of \$112,893. The proposed budget for 2022 is \$469,240 which reflects the combination of the mortgage being paid off and the final year of the Roots & Wings funding.

A financial review was completed between PCO and the First Presbyterian Church of Holt where each church examined and commented on each other's financial operations and procedures. Doug Paterson and Dave Detrisac handled the review which covered both 2019 and 2020 since the review of 2019 was held off until now due to the pandemic. Several action items were identified for follow-up.

Work continued on planning for future large scale capital projects in conjunction with the newly established Capital Improvement Fund. The foundation of this fund resulted from a gift from Bill Fritz and family, part of which was used to pay for parking lot repaying.

As of December 31, 2020 the General Fund balance was \$31,726 despite the disruptive nature of the pandemic on people's lives and the operation of the church.

Memorial Fund oversight responsibilities were clarified in regard to accounting, record keeping and acknowledgement of contributions. The Endowment Committee agreed to assume this responsibility since it is very similar to its role relative to the Endowment Fund. Updated Memorial Fund by-laws were approved by the Endowment Committee and will be submitted for approval by the congregation at the 2022 Annual Meeting.

Our committee, working with Pastor Peggy, worked on several **policies and procedures** to be addressed prior to the new pastor coming on board. The development of an emergency management plan was the final piece completed as part of the church's operations manual. A formal single page history and policy for the Memorial Garden was developed. Working with Matt Pearson the livestreaming equipment and software was ordered and installed. Funding of the livestreaming system was made possible as a result of the Chris Doemel bequest and a plaque reading "In appreciation of the gifts of Chris Doemel" was affixed to the livestreaming cabinetry out of respect for the interest Chris had in technology and music.

Building and Grounds activities are tracked and reviewed at the monthly committee meetings. In prior years volunteer property team members addressed tasks around the church but Sexton Edward Ennen has taken on the bulk of the responsibilities and has done a wonderful job addressing needs of the facility. Dave Rumminger worked with Edward to paint the four primary offices along with oversight of carpet replacement for all four offices. Gary Sturk led the annual cleanup day which took place in the spring. Gary also installed a handrail for easy access along the west wall of the sanctuary to the pulpit area.

Progress was made in key areas of need including the repaving of the church parking lot. Cold weather precluded resolution of two problem areas which will be addressed in the spring. A contract was executed with F.D. Hayes Electric to repair or replace much of the lighting in the sanctuary including the five lighting tracks, recessed cans and spotlights as well as the recessed lighting under both canopy entrances. This work will take place in January to be followed later in 2022 or 2023 with a possible upgrade of the pendant lighting. A-1 Pro Services was brought in to take air samples which confirmed the mold problem of 2020 was resolved. Results showed zero mold spores in the church basement.

Building Use activities are reviewed by the entire committee and coordinated with Dave Rumminger, who continues in the role of Key Master.

Green Team formation occurred in March, 2021 with thirteen (13) church members initially joining the team. The Green Team reports through the Administration Committee. Subcommittees have been established in areas of interest including native plants, recycling, composting and solar energy. The Green Team also participates with the Capital Area Chapter of the Michigan Interfaith Power & Light organization. One activity with the Capital Area Chapter involved fundraising for solar panels for a Lansing community organization called the Southside Community Coalition. PCO members contributed \$2250 to the successful campaign.

In December the Administration Committee advanced a motion to Session to consider committing PCO to become a PCUSA Earth Care Congregation. An application template and other information was shared so that Session could discuss this more fully at the January Session meeting.

We appreciate the support of the church membership and all of the other committees that are so helpful to us throughout the year. We also appreciate the church membership for supporting the church budget this past year.

PRESBYTERIAN CHURCH OF OKEMOS GREEN TEAM REPORT- 2021

The Green Team was formed in March, 2021 with thirteen (13) church members initially joining the team. The Green Team reports through the Administration Committee. Subcommittees have been established in areas of interest including native plants, recycling, composting and solar energy. All activities of the Green Team are done with the desire to preserve God's creation.

Scott Locke is working with Jennifer Gordon and Jerri Gillett in developing plans for a native plant project in spring, 2022. Over the next several years the group is planning to slowly amend the non-ornamental part of the PCO landscape (such as the rain garden in front of the church) and convert some of the unused turf grass sections to native plants and shrubs. Native plants have many benefits over exotic/non-native plants. Our team will work to educate the congregation about the benefits of native plants via Grapevine articles, minute for mission, and thru the church website for links to other resources.

A composting strategy has been developed by Jeff Conroy-Krutz and will be deployed in early 2022. We will be installing an outdoor tumbling composter along with a countertop compost container for the kitchen. These will be used to capture organic kitchen waste from on-site food preparation and consumption along with paper towels, napkins, pizza boxes, flowers and coffee grounds. This initiative will also include an educational component for the congregation through the Grapevine and minutes for mission. This would educate those who use the kitchen to place the compostable items in the dedicated container. We also hope this will encourage church members to consider composting in their homes and businesses.

Dorinda VanKempen continues to oversee the recycling efforts at the church. She is currently working to obtain green product options for cups and takeout containers to be used when we don't use real cups or have a need for takeout containers. These products can be composted and begins a move away from styrofoam to save products from the landfill that don't decompose.

The solar energy subcommittee members include Bill Given, Ewen Todd, Jeff Conroy-Krutz, Kent Workman and Jeff Arbour. This team is exploring potential solar panel configurations for PCO to leverage a renewable energy source and to reduce carbon dioxide emissions that are contributing to global climate change. This renewable alternative has the potential to save significant dollars for the church over the coming years. A second area the team is focused on is leveraging formation of a limited liability corporation (LLC) to allow the church to take advantage of the federal 26% tax credit for renewable energy projects. The LLC approach will also keep the cost of the solar panels off the church budget. This approach has been leveraged by several other houses of worship in Michigan.

The Green Team also participates with the Capital Area Chapter of the Michigan Interfaith Power & Light organization. One activity this past summer involved fundraising for solar panels to support a Lansing based community organization called the Southside Community Coalition (SSCC). The goal was to take a positive environmental step in providing a renewable energy source that will eliminate the electric bills for the SSCC freeing up monies for more productive uses in the community. The PCO Mission Committee provided a base \$500 contribution and combined with individual contributions from PCO members a total of \$2250 came from PCO to support the SSCC initiative.

In December the Administration Committee advanced a motion to Session to consider committing PCO to become a PCUSA Earth Care Congregation. An application template and other information was shared so that Session could discuss this more fully at the January Session meeting. A commitment to become an Earth Care Congregation would create potential for significant additional activities for the Green Team in conjunction with other church committees.

Annual Report Adult Education

Highlights/Accomplishments in 2021

The mission of the Adult Education Committee is to enhance the faith of members through information relating to Scripture and society and our roles at PCO to increase our knowledge on how to respond to issues in church and community. Such education should encourage personal and corporate spiritual growth and make us to be welcoming to visitors and new members.

Meetings were held monthly through Zoom throughout the year with opening devotions given by chair Ewen Todd and closing prayers by pastors when they were present. The Committee was appreciative of Laurin Gierman's leadership over her term of three years. She was replaced by Ewen Todd who will be Chair reporting to Session for 2021 through February 2024. In the spring, the Committee added three new members, Cathy McCarthy, Jill Schaberg and Michelle Nessa. Matt Pearson was guest attendee to help set up the survey of members input for Adult Ed, and the zoom technology for Sunday mornings (along with Yusef Sultani and Carl Lira). In December Bob Boldrey tendered his resignation after 6 years of effective contribution. We will miss Bob's insightful comments and background digging for information on potential speakers. Adult Education includes Sunday morning talks but also other educational events at other times, including Lenten and Advent devotions. In the spring Words Matter (PCUSA, 2015) were selected for Lenten devotional beginning on Ash Wednesday evening and extending on every Sunday evening at 7 pm till Easter; these were well led by members Schabergs, Nortons, and Gradys. On three Advent Sundays evenings at 7-9 pm, Pastor Lisa Schrott led a discussion of what each of the gospels say about the birth of Jesus. She also coordinated the discussion on personal devotional PCO material for Advent.

Adult Education Sunday mornings talks were held in the Boardroom and the Chapel both in person and on Zoom, generally from 11: 20 am to around 12:30 pm. No coffee was available because of COVID restrictions on food, but attendance was generally good whether on Zoom or in person. In February we had conversations facilitated by retiring Adult Ed chair, Laurin Gierman, with Pastor Alice Townley on mission and education. Appreciations were expressed to Alice and her family for all they have done in the congregation. Alice responded by saying it was a shared responsibility with the congregation which would manage fine with its lay leadership for future programming. Pastor Peggy Huston hosted a spring Zoom Saturday morning series and a Sunday afternoon series on open-ended faith questions where topics included predestination, inclusive language, and exploring children's faith questions. In March, Judi Harris and Paula Franz gave updates on refugee status and how the Global Institute of Lansing (GIL) was functioning in times of COVID. There were two presentations by Dr. Roy Meland on COVID affecting loneliness and mental health (July and December). In addition, Choir director Colleen Chester discussed church music and choirs; Ken Bieber (Riverside Terrace) on Interfaith interactions; John Best (retired Presbytery) on disabilities. In the interim period between pastors, John Best and Ewen Todd separately led discussions on transitions, and Jim Kocher on Reformation, and a panel of Bill Given, Jill Schaberg and Jim Kocher shared thoughts on gratitude for stewardship. UKirk Presbyterian students discussed sharing their faith in the MSU community. Kiss the Ground film was shown in conjunction with the PCO Green Team. Israeli and Palestinian relationships were reviewed with Peggy Huston who had been to Israel and later Rev. Elmarie E.R. Parker PCUSA who talked on the crisis in Lebanon and Stav Brener of the Israeli Community Shaliach of the Jewish Agency for Israel who talked on Israel's relations with other Middle East countries. Michelle Nessa reviewed the member on-line survey of preferred topics and times for Adult Ed. On September 21, 7-8 pm members watched on Zoom the Capital Region Interfaith Power and Light Chapter sponsored talk on Floods, Droughts and Wildfires: How Climate Change is Affecting Our Weather by Dr. Nathan Moore, Associate Professor at Michigan State University. Mission: Joy, a film about the joyful faith journeys of the Dalai Lama and Desmond Tutu was shown and discussed on November 21, 7-9 pm. It was much appreciated by those who saw the film. The December Afghan refugee status was shared by Yusuf Sultani on the Afghan country and culture, and Judi Harris on Afghan resettlement in the Lansing area. Lisa conducted sermon talk backs in December on Advent themes and the theology of Advent and Christmas hymns.

There was limited participation in outdoor events. Walk from Hartrick Park towards Okemos Road' and MSU Bird Observatory at Burke Lake Banding Station. But more will be pursued in 2022.

<u>Library</u>. This has not been well patronized in 2021, partly because of limited PCO attendance because of COVID restrictions, but partly because many people search and read literature on-line today. A subcommittee is being set up to review the purpose of the Library for PCO members and the Committee welcomes volunteers. However, videos and books on Islam and Christianity were reviewed for the Grapevine. All were considered useful for those who wish to learn more about Islam and the Quran to understand what Muslims believe. *Approaches to Islam: Theological and Practical* by David Shenk is a 15-lecture series to explore the Christian faith and Islam and how two communities can be engaged with each other in peacemaking ways. Books were *Islam: What Non-Muslims Should Know*, Revised & Expanded Edition By: John Kaltner; *The Bible and the Qur'an: Biblical Figures in the Islamic Tradition* by John Kaltner, Younus Mirza; *The Islamic Jesus* by Mustafa Akyol. Photographs of church events are taken by Mary Lou Gifford and other PCO members and are put in albums in the Library. It is important that members recognize the legacy we create over the years.

Plans/Vision for 2022

Opportunities for learning and Christian formation include Bible Studies, Advent and Lenten reflection groups, contemplation and meditation, book discussions, field trips, interfaith forums to continue increasing our understanding of each other's faith traditions, community events, and retreats in consultation with the pastors. One example of interfaith exploration is sharing Lent traditions with members of the Islamic Center in the future. The Green Team is forging links with other Houses of Worship, and Adult Ed will partner with the Team to find speakers to broaden our knowledge and commitment to ecojustice and other environmental issues. The Committee also reviewed the input of the Self-Study prepared for hiring our pastor for input into adult education in general and more specifically conducted an on-line survey led by Michelle Nessa for member input into Adult Ed topics which will be reviewed for ideas in 2022.

Associated Adult Education Groups in the Church

The Adult Education Committee acts an "umbrella" structure for different congregation groups involved with adult discussions and studies. It does not influence the activities of these groups, but can help facilitate links to Session including funding proposals and taking joys and concerns they may have.

Artist Circle has met most Tuesday afternoons by Zoom or in person. This year we also visited the MSU gardens and an exhibit at the Broad Museum. We help with liturgical art for the sanctuary and bulletin boards. We have a mixed range of skills but are all interested in creating art and discovering how art enhances and lets us express our faith. Art and creativity are a big umbrella. We welcome visitors and those who want to join, both men and women. No matter your artistic abilities, we learn and laugh together. Whenever others join us, we are all enriched. The Artists Circle coordinated by Jennifer Gordon and Eunice Creswell.

Caregiver Support Group. A Brain Support Group was started in December and currently meets the third Tuesday of each month on Zoom. Currently, the caregivers are attending and so the name and focus was

changed to the Caregiver Support Group. An open-discussion format has met the needs of the group. Activities, resources, support for each other and conversation are important components of each meeting. It is currently coordinated by Jane Bobay.

The Conversation and Contemplation group met on a regular basis in 2021 starting with a series of 12 sessions hosted by Anita Smith Buckwalter, retreat leader and Representative at Church of Brethren, and subsequently by group members with a focus on contemplative prayer. The group has prepared a mission statement to help members focus on future activities.

The Men's Group coordinated by Doug Paterson meets every Tuesday morning at 8 am with a range of topics including open-ended discussion on Faith Questions and reading books, but there is no specific agenda; members simply converse.

This past year the PCO **Race and Justice** group has been facilitated by Kent Workman with input from PCO members. The group meets two Thursday evenings a month. We have used books, podcasts, videos and more to stimulate our discussions. Topics have included racial issues, white privilege, bias, incidents of hate, structural racism, and more. All are welcome to participate and take turns in leading discussions.

The Retiree Group has met twice monthly, the 2nd and 4th Mondays, in Fellowship Hall or on Zoom. Topics were decided by members each month and covered traditions, meaningful celebrations, favorite fall activities, what we do for fun, Christmas stories, movies, books, and. Some weeks, question starters lead to interesting discussions. It is coordinated by Jane Bobay.

The **Thursday morning Adult Bible Study** led by Ewen Todd is held most Thursdays on Zoom throughout the year between 9:30 and 11 am. In 2021 we studied The Book of Ruth, N. T. Wright courses on 1) 15 Essential Bible Texts and 2) Surprised by Hope, both led by N. T Wright, and Ruth Sandberg on comparing Judaism and Christianity. For Advent we went over the historical and cultural background for the gospel texts and read related dramatized stories written by Ewen. At each meeting, participants shared joys and concerns, and one would volunteer to close in prayer. We had attendees from Beirut, Lebanon and Guelph, Ontario who joined those at PCO.



While most Thursday morning Adult Bible Study sessions were held online, the group was able to gather for a picnic during the summer.

Writing Life Stories has spent the last year reading members' poetry, short stories, letters, interviews, family reminiscences, and autobiographical vignettes. Discussion follows such reading. People can come to converse without contributing something they have written. We meet on Zoom at 2:00 p.m. on the first Sunday of each month, including summer meetings. Presbyterian Church of Okemos 2021 Annual Report Christian Education for Children and Youth

In February 2021 Session divided the Christian Education Committee responsible for child, youth, and adult Christian Education into two separate committees, Christian Education for Children and Youth and Christian Education for Adults. These two committees were chaired by different elder members of Session. This annual report addresses Christian Education for Children and Youth (CECY).

1.**Committee Formation** - New members for the CECY Committee were recruited in February and early March of 2021. The recruitment efforts were focused upon increasing the representation in the committee of parents of school age children and youth. A significant number of parents agreed to participate in the work of the committee. Over the course of the next few months, a few of the new members resigned from the committee citing family scheduling issues that conflicted with their participation. Nonetheless, there remained a number of parent members of the committee.

2.Sunday School Teacher's Meeting – For a number of years the Sunday School Teachers meet monthly as a separate group from the Christian Education Committee. Beginning in April 2021 the separate Sunday School Teacher's Meeting was discontinued and the Sunday School Teachers joined the CECY Committee.

3.Zoom Sunday School – Due to the Covid pandemic, regular Sunday morning Sunday School was put on hold in 2020. Weekly Zoom Sunday School was initiated and continued through June of 2021. There was a small core of children and youth who participated but there was no mechanism for accurately collecting attendance. Anecdotal review suggested that children and youth who were participating in online regular school were tiring of remote education activities. Sunday School was discontinued in June for the summer.

4.Director of Christian Education – With the loss of the part-time Associate Pastor in the spring of 2021, Session voted to combine the part-time pastor position with the part-time Director of Christian Education position into a single full-time associate pastor position. As a consequence, the part-time Director of Christian Education Education position was discontinued in June of 2021.

5.Safe Environment for Children/Youth – As there was no written policy and practices regarding safety for children and youth, the CECY Committee developed one that was approved for implementation by Session in September 2021. The policy included obtaining clearances for all staff and volunteers working with youth from the Michigan State ICHAT system. Subsequently all clearances were obtained.

6.Family Camp – As a consequence of the Covid pandemic and lack of available leadership, there was no organized participation in the traditional Memorial Day Weekend Family Camp in 2021. One or two families from PCO did participate on their own.

7.Summer Bible School – An outdoor summer bible school day in conjunction with two other local churches and focusing upon the Project Heifer Bee Keeping mission was planned by representatives of all three churches. However, only a couple of children registered for the event so the planning group decided to reschedule it for next year when there might be less Covid impact. Subsequently, the park where the event was going to be held was severely flooded on the scheduled date.

8.Youth Group – The Youth Group for middle and high school youth continued to meet via Zoom through early June 2021. In June an outdoor in-person social gathering was held at PCO with 8-9 youth participating. Also in June the Youth Group participated in gathering tools for the CASS program in Detroit. Only one youth group member and a younger sibling participated. Other Youth Group activities during 2021 included a Meet

the Pastor luncheon, a Get to Know the Church scavenger hunt, a trip to a Corn Maze, and making ginger bread houses.

9.Youth Group Coordinator – The youth group coordinator, who had been working with the youth group through June 2021, moved to Texas to further his education and was therefore unable to continue. The CECY Committee developed a new job description for a new Youth Group Coordinator and sought applicants. A joint CECY/Personnel Committee sub-group was unable to recruit an appropriate person for the position and efforts to find someone were discontinued in early December 2021. The CECY Committee continued to plan Youth Group activities which were led by an assortment of youth parents.

10.Sunday School – In person Sunday School resumed in September 2021 with as Rally Day kickoff. The CECY Committee/Teachers chose to use the *Feasting on the Word* curriculum for all grades. We were able to recruit full complement of teachers and substitutes for the five classes (pre-school through high school). A new online system for taking attendance was implemented in September 2021. From September through December of 2021 the average attendance at Sunday School has been 9 youth. The high school class has been the best attended with a typical attendance of 4-5 youth each week. The younger classes have had very weak attendance with usually no more than one or two children in a class. Some weeks some classes had no children attending.

11.Challenges -

1a. Participation by children and youth in Sunday School and Youth Group has generally been very weak. How to revive these activities or to identify alternate activities that will meet the Christian Education needs of children and youth of the congregation is an important goal.

2b. Sunday School is served by a very dedicated group of teachers and substitutes. However, a number of them have been participating for many years and are likely to be retiring in the future. Finding replacement teachers will be a challenge.

3c. Sustaining the Youth Group has been difficult without regular leadership. We will need to procure regular leadership for the Youth Group.

4d. Recovering from the effects of the Covid pandemic on the participation in our congregation of children and youth will be a challenge.

Pastoral guidance was provided by Rev. Alice Townley, Rev. Peggy Casteel-Huston, and Lisa Schrott.

Meetings: The committee had a planning meeting and in compliance with PCO's COVID task force guidelines, all monthly meetings in 2021 were held on Zoom.

Focus: Overall, the committee focused on welcoming and supporting refugees; fighting poverty and violence; feeding those in need; providing shelter for those in need; supporting education for youth in need; supporting cross cultural relations, economic development and health through mission work in Niger; fostering community relations and education for less privileged girls in Kenya; and supporting global health initiatives, especially in Haiti.

Activities: The committee's approach to hands-on activities this year took a different form this year due to the persistence of the coronavirus pandemic. Food and beverage were missing at all but one event, some activities related to COVID like the PPE bags, and sometimes items were just left at the door. The committee appreciated guidance from the PCO COVID Task Force to help ascertain safe practices for church members and those being served. Here is a summary of our activities:

- Community Virtual Fund Raiser for Afghan Refugees/evacuees supported by State Representative Julie Brixie. Ellen Hoekstra organized the event with supporting roles played by many in the PCO family including Pastor Lisa Schrott, Yusuf Sultani, Judi Harris, and other in the church's support team.
- Prayer Vigil at the State Capitol building in support for Afghan Refugees/evacuees. Organizers from OPC included Yousef Sultani and Judi Harris. Pastor Peggy, Kent Workman and David Horner attended.
- Organized the collection of kitchen supplies for Afghan Refugees/evacuees.
- Joint project with the youth to collect new and gently used tools for Cass.
- Mission trip to Cass in Detroit to organize and ensure the working condition of the tools collected from various sources by Cass. Nine committee volunteers participated in this trip included Keith Camann, Jennifer Gordon, Ellen Hoekstra, David Horner, Beth Layhe, Mary Schuring, Wayne Scott, Gary Sturk, and Kent Workman.



- Crop Walk was virtual again this year, but 22 people registered and raised \$11,256.
- Several groups brought meals to Advent House in this past year
- PCO has continued its monthly meal to Loaves and Fishes.
- Thanksgiving Basket project continued its partnership with Okemos Community Church and Darla Jackson of Meridian Township. Meijer \$75 gift cards were given to local families to purchase food for a holiday meal. Thanks goes to Becky Gillespie for organizing and coordinating this annual event. \$2530 from PCO.
- 50 Blessing Bags/purses were filled with personal needs for newly arriving Afghan women. Jayne Zuhlke and Becky Gillespie coordinated this project
- Christmas Giving Tree project, coordinated by Trudy Sturk, collected \$6,300 for 18 people in 3 families. Each person received \$300 in gifts and each of the 3 families received \$275 in Meijer gift cards for food.
- PCO was represented at the Communities in Schools (CISM) Leadership in Education dinner by Pastor Peggy Casteel-Huston, Jeff & Michele Arbour, Ellen Hoekstra, David Horner with Mori Rothhorn and Kent Workman.
- Members participated in two "packing" events for mid-Michigan Communities in Schools Michigan, which serves the Lansing and Waverly Districts. The first was packing 50 PPE kits, and 10 members had a St. Patrick's Day celebration to fill and prepare these bags last March. The second took place on September 13 and ten members joined CISM staff to fill school supply bags for 500 local children.



Beyond the committee's efforts, PCO and individuals within PCO made significant additional contributions. This includes time, talent, and funding. Time and talent contributions included Judi Harris's leadership with St. Vincent Catholic Charities Refugee Services; Paula Frantz's leadership with the Global Institute of Lansing (GIL); Andrea Kaitany's leadership with Simbolei Academy; Tom Schaberg's work with Edgewood Village; Bill Given's work with Advent House; Ellen Hoekstra's work with Communities In Schools Michigan and Cass Community Social Services; Diane Allen's work on Crop Walk; and Barbara Dorr's work with Loaves and Fishes Ministries, Keith Camann and Gary Sturk leadership in the CASS tool project, Kent Workman with Ukirk, Becky Gillespie and Trudy Sturk for their contributions to Thanksgiving and Christmas events and Jayne Zuhlke for working behind the scenes for many projects.

Funding: Most funding goes toward serving local needs. The chart below shows how the \$40,000 from General Mission budget was distributed by activity:

The session allocated the balance of the 2020 general budget (\$26,824) to the Mission Committee to address local COVID related needs. These funds were used to support the following organization: Advent House; CISM, Greater Lansing Food Bank, Haven House, Loaves & Fishes and the Okemos Community Church.

The Designated Mission Fund received over \$33,000 from individuals and/or group events. These funds are designed for a specific organization or project. The major benefactors in 2021 were Church World Service (CROP), Simbolei Academy, Refugee Services, Christmas Giving Tree, Advent House, and Greater Lansing Food Bank among others.

Following national and state government policy on social justice issues: The committee received monthly updates on federal and state legislation being proposed or enacted that would create new policies or change current policies related to social justice. Public policy is part of the government safety net for the well-being of all people. As Ellen Hoekstra has explained, "*Our church donates funds, food, and labor to help feed the hungry, but public policy can help meet this need as well.*" Being informed about the bigger picture helps the committee best target how we distribute our resources of time, talent, and funding.

Finally, it needs to be noted that the mission activities and funding in this report are only part of the contributions made by the congregation and staff members. More time and talent is provided than ever recorded and more giving is done on-line and through venues we do not track as a committee. For example, 22 walkers, rockers, and supporters generated \$11,256.00 for Crop Walk in 2021 – a major accomplishment.

PARISH LIFE COMMITTEE ANNUAL REPORT FOR 2021

The Parish Life Committee spent this year helping church members say Farewell, and then Hello and Welcome. Events took place on the church lawn, always with Covid safety regulations in mind. Deb Major set up a KudoBoard before the Townley Family Outdoor Farewell on May 16. This was a chance to catch up with Alice and her family after Alice's sabbatical. We said goodbye to Conner Koppin and Sue Schnackenberg at the church picnic on June 13. Kathy Richardson presented them with personal bags that she had made. At these gatherings, church members had the opportunity to bring cards that expressed their love and appreciation.
